



**TEMPORARY CLOSURE OF PART OF VARIOUS ROADS, PARISH OF CHALFORD, STROUD DISTRICT**

Gloucestershire County Council has made an order to temporarily close under the Road Traffic Regulation Act 1984 (as amended) part of the lengths of roads as detailed in the schedule below.

The reason for the closures is to undertake fibre installation works .

The roads were expected to be closed and restricted on a rolling programme commencing on the 29<sup>th</sup> May 2018 and works complete by the 12<sup>th</sup> July 2018. However due to circumstance beyond the control of Gigaclear works ceased.

The road are expected be closed and restricted on a rolling programme commencing on the 4<sup>th</sup> February 2019 where the presence of approved signage will indicate whether the closures are in force, further, advance warning of dates/times will be displayed on site prior to the closures and restrictions taking effect. This Order can permit the closures and restrictions of the roads in any order, or simultaneously, as required and it is anticipated all works will be completed by 31<sup>st</sup> March 2019. Works that have been “complete” before the suspension of the closure will not form part of the works.
