AGENDA ITEM 08 - PLANNING APPLICATIONS TO BE CONSIDERED ON 17th JULY 2025

- S.25/1034/TCA** Pumping Station 16m from Heber Ltd Belvedere Mill Chalford Industrial Estate - 4 Ash trees - crown-reduce by 5m where possible. The remaining lower branches are to be cut back to the fence line approximately 2m.
- S.25/1179/TCA** 5a & 21 Chalford Industrial Estate - Apple Tree - Crown reduction 10-20% (1m from longest branches).
- S.25/1241/TCA** 33, Belvedere Mews, Chalford - T1. Spruce tree - Remove. T2. Conifer tree - Remove. T3. Goat willow tree. Re-pollard back to previous points. 2-3m reduction. T4. Alder tree -Reduce height by 2-3m. T5. Alder tree - Reduce the few low overextended branches overhanging the carpark area by 3-4m.
- S.25/1071/HHOLD** 45, Frithwood Park, Brownhill, Chalford - Erection of single storey side extension and alterations to existing storage building.
- S.25/1155/HHOLD** Bryn Cottage, Abnash, Chalford Hill - Erection of single storey rear extension
- S.25/1185/HHOLD** 12 Munday Close, Bussage - Erection of a detached double garage & extension to the existing block paving driveway to accommodate vehicular access
- S.25/1202/HHOLD** 15, Bluebell Chase, Chalford - Erection of single storey rear extension
