## PAC 09.31.03.23 NEW PLANS

1560 S.23/1483/HHOLD – La Clusaz, The Ridge, Bussage – Extension to rear of the property – resubmission S.22/0587/HHOLD & S.22/2705/HHOLD - Cllr. Beioley proposed "we support plan" This was seconded by Cllr Trinder and unanimously agreed.

1561 S.23/1560/LBC – Valley Cottage, High Street, Chalford - Erection of a rear two storey extension & associated landscaping – resubmission S.22/0458/LBC. Cllr. Trinder proposed "we support plan 1561 in principle, but common ownership of the parking area and property must be maintained and the car park surface should be Cotswold stone chippings to stay in keeping with the listed building consent" This was seconded by Cllr. Morris-Wyatt and unanimously agreed.

**1562 S.23/1616/TCA - Charnwood, Brownshill – Blue Atlas cedar tree – fell to ground level.** Cllr Morris-Wyatt proposed "**The committee agreed that this tree is of high amenity value and could be managed with regular pruning rather than felling.**" This was seconded by Cllr Trinder and unanimously agreed.
