PAC 04.22.02.24 MINUTES OF LAST MEETING – Cllr Pearson proposed "we approve the minutes of the 1st February 2024" This was seconded by Cllr. Lee. There was one abstention.

## **PAC 08.22.02.24 NEW PLANS**

S.24/0162/TPO - Brownshill House, Brownshill Road, Brownshill - T1 - Sycamore. Crown Raise to 6 metres. The majority of the lower limbs, which directly overhand the adjacent road & private driveway, are dead. Recommendation for crown raise to 6 metres to remove all dead & damaged lower limbs. T2 - Sycamore. Complete removal. This mature tree leans directly over the adjacent road & power lines, and towards the neighbour's property. T3 - Ash. Complete removal. Clear signs of Ash die-back disease. T3 is located adjacent to T2 and thus presents similar cause for concern. Cllr Lee proposed "support plan 1603". This was seconded by Cllr Pearson and all agreed. Action: Deputy Clerk

S.23/2440/HHOLD - The Tyning, Highfield Way, France Lynch – Convert and increase roof height of existing garage, construction of a new garage, rear two storey extension and new dormers (revised plans received 07.02.24). Cllr Trinder proposed "support plan 1604". This was seconded by Cllr Pearson and unanimously agreed. Action: Deputy Clerk

**S.24/0173/HHOLD - Pear Tree Cottage**, Rack Hill, Chalford – Installation of replacement windows. Cllr Trinder proposed "support plan 1605". This was seconded by Cllr Pearson and a unanimously II agreed. Action: Deputy Clerk

S.24/0187/HHOLD - Windermere, Middle Hill, Bussage – Erection of a single storey side and rear extension. Cllr Trinder proposed "support plan 1614". This was seconded by Cllr Pearson and unanimously agreed. Action: Deputy Clerk

S.24/0251/TCA - Cavanbah, Bussage - T1 Ash - repollard to previous points. Removing approx. 2.5 growth. T2 - maple, fell. Cllr Pearson proposed "support plan 1609". This was seconded by Cllr Trinder and unanimously agreed. Action: Deputy Clerk

**S.24/0261/TCA - Woodview, High Street – T1 Ash – fell.** Cllr Pearson proposed "**support plan 1610**". This was seconded by Cllr Trinder and unanimously agreed. **Action: Deputy Clerk** 

S.24/0249/HHOLD - Wild Rose Corner, Cowswell Lane, Bussage – garage conversion and extension to form annex, incidental to dwelling house. Cllr Trinder proposed "support plan 1607 subject to it being retained as incidental to dwelling and not for individual occupation or letting for short term holiday lets.". This was seconded by Cllr Lee and unanimously agreed. Action: Deputy Clerk

S.24/0255/TCA - Riverdale, High Street, Chalford – T1 walnut – fell. T2&3 Sycamore – fell. Cllr Pearson proposed "support plan 1611". This was seconded by Cllr Morris-Wyatt and unanimously agreed. Action: Deputy Clerk

S.24/0288/HHOLD - 42 Stonecote Ridge, Bussage, - erection of a two storey side/rear extension and single storey side extension. Cllr Trinder proposed "support plan 1613". This was seconded by Cllr Lee. There was one abstention Action: Deputy Clerk
