PAC 01/07.08.25 - APOLOGIES - Cllrs Trinder and Lee,

PAC 02/07.08.25 - PUBLIC PARTICIPATION –A resident, who advised they also represented the views of two of her neighbours, attended regarding the planning application for Hyde View. An objection had been sent to SDC but was not on SDC portal before the meeting and so the text was circulated by the Deputy Clerk the afternoon prior to the PAC meeting. The objection was on the basis of loss of privacy, overbearing impact, impact on visual amenity in an AONB and potential daylight reduction.

PAC 06/07.08.25 - **CORRESPONDENCE** – an email had been received asking if the Parish Council has any control over the ever-growing number of Air B&B's. The Planning Committee confirmed that the Parish Council does not have any control over short-term holiday lets.

PAC 07/07.08.25 - ANY RESULTS FROM SDC ON PREVIOUS APPLICATIONS

Consent: S.25/1179/TCA – 5A & 21 Chalford Industrial Estate – we supported this plan.

Permitted: S.25/0798/FUL - Stable, Middle Hill - The Parish Council is concerned about further encroachment of the defined settlement boundaries and the precedent set for additional development beyond the boundary. However, in view of the changes in national planning policy concerning conversion of rural buildings since previous applications were considered, and the quality of design of the scheme, we support the proposals. S.25/1045/HHOLD - Field House, Randalls Green - Whilst we do not object to the principle of a well designed extension, we object to this planning application on the basis that the form and design of the proposed extension - in particular the extent of the flat roof - is not in keeping with the scale and character of the original dwelling and therefore does not meet the requirements of Policy HC8 of the Local Plan. S.25/0830/HOLD – 18 Burcombe Way, Chalford Hill - Erection of single storey rear extension and garage conversion.

Blanfords, Cowswell Lane, Bussage - G1 - Crown reduce group of lime trees by approximately 30 percent (3-4 meters in height to be removed). Remove 3 heavily leaning stems. Cllr Humberstone proposed "we support this plan" This was seconded

by Cllr Beioley and unanimously agreed.

S.25/1329/TCA Cotswold Lodge, Brownshill - Lime tree - branches which stick out into the road to be cut back approx 2m. Cllr Humberstone proposed "we support this plan" This

was seconded by Cllr Pearson and unanimously agreed.

S.25/1365/TCA The Dortor, Bussage - Holly and Yew tree - removal. Cllr Beioley proposed "we support this planning application but ask that under Delivery Policy ES8, that

where the loss of trees is considered acceptable, adequate replacement

provision will be required that utilise species that are in sympathy with the character of the existing tree species in the locality and the site." This was seconded by Cllr Taylor and unanimously agreed.

Bussage House, Bussage - T1. Silver Birch - removed to ground level. Cllr Beioley proposed "No comment as there is no justification offered for the tree removal." This was seconded by Cllr Humberstone and unanimously agreed.

Hyde View, The Frith, Chalford - Erection of a two storey side extension, porch and loft conversion. Cllr Beioley proposed "we support the application in principle but ask that the Planning Officer consider neighbouring residents' concerns regarding scale/mass and subserviency to the existing property, the impact on the streetscape and possible overlooking from the new roof lights given the angle of the hillside". This was seconded by Cllr Taylor and unanimously agreed

Briar Bank, Abnash, Chalford Hill - Erection of a two storey front and side extension. Replacement outbuilding with air source heat pump.
