



**TEMPORARY CLOSURE OF PUBLIC FOOTPATH MCH59 AND MCH60
(CHALFORD PARISH) STROUD DISTRICT**

Gloucestershire County Council has made an order to temporarily close under Sections 14, 15 and 16 of the Road Traffic Regulation Act 1984 (as amended) Part of Public Footpaths MCH59 and MCH60 as defined in the Schedule below;

SCHEDULE

Public Footpath MCH 59) from its junction with MCH 58 at Ordnance Survey Grid Reference (OSGR) SO 89734/02570 extending in a generally easterly direction for a distance of approximately 205 metres to its junction with the High Street at OSGR SO 89934/02571 and shown on the Map by a bold solid black line marked A to B.

Public Footpath MCH60 from its junction with MCH 59 at Ordnance Survey Grid Reference (OSGR) SO 89898/02582 extending in a generally north easterly direction for a distance of approximately 85 metres to its junction with the MCH 56 at OSGR SO 89939/02625 and shown on the Map by a bold solid black line marked C to D.

The public footpath falls within the Chalford Parish in the Stroud District, Gloucestershire.

The closure is necessary for safety reasons due to a collapsed wall.

The footpath was originally closed for 21 days by emergency notice commencing 28th October 2019. However, as the works to remedy the problem have not been completed it is necessary to close the footpath by an Order which can authorise the restriction for up to six months from the date of the first notice.

This temporary order comes into effect on the 18th November 2019. If work is not completed by 28th April 2020, then it will be necessary to make an application to the Secretary Of State for an extension to the Order.

There is no alternative Route.

Pedestrian access and emergency access to adjoining properties will be maintained at all times.
