



**TEMPORARY CLOSURE AND RESTRICTIONS OF VARIOUS ROADS  
(CHALFORD AND MINCHINHAMPTON PARISHES)  
STROUD DISTRICT**

Gloucestershire County Council intend to make an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close and restrict part of the roads as detailed in the Schedule below.

There will be no parking or waiting permitted throughout the duration of the works.

The reason for the closures and restrictions is for works for Fibre Optic installation.

The roads are expected to be closed and restricted on a rolling programme commencing 1<sup>st</sup> March 2021, where the presence of approved signage will indicate whether the closures and restrictions are in force. Further advance warnings of dates/times will be displayed on site prior to the closures and restrictions taking effect. This order can permit the closure and restriction of the roads in any order, or simultaneously as required and it is anticipated all works will be completed by 30<sup>th</sup> June 2021.
